

# Entirely People Limited

## Privacy Policy

Entirely People Limited (“we” or “our”) respects the fundamental right to privacy and the protection of personal data and is committed to providing a service that adheres to the General Data Protection Regulation (GDPR). This policy applies where we are acting as a data controller with respect to the personal data of data subjects, including our clients, candidates and website users; in other words, where we determine the purposes and means of the processing of that personal data.

In order to deliver our provision of Executive Search & Selection Consultancy / Recruitment Services, it is necessary for Entirely People Limited to process & store personal data. When doing so, we adhere to the following principles in order to protect your privacy:

- we do not collect more information than is necessary;
- all data processed by Entirely People Limited will be sourced lawfully and stored on a secure, password protected, cloud-based Recruitment platform.
- we do not use your data for anything other than recruitment purposes and it is only processed where there is a contractual necessity, consent has been given, or where we have a legitimate interest;
- we do not keep your data if it is no longer needed;
- personal data will only be shared in delivery of a recruitment process, once approval has been granted to do so by the data subject.

### Candidate Data

#### **Why will we process your personal information?**

To enable us to provide the solutions and services expected of a Recruitment Partner to individuals interested in exploring the job market and potential opportunities.

#### **What personal information will we process?**

In basic terms this will include the minimum to maintain an ongoing communication channel. This may include (but is not limited to); name, phone number, private email address, links to public professional profiles, but may extend to more detailed information as deemed essential to deliver more advanced services, for instance when a candidate is actively involved in a recruitment process. This may include (but is not limited to); Home address, Resume, Interview notes, Financial information, employment preferences.

#### **Where do we get your data from?**

When you have approached Entirely People direct; if you have submitted your details to an online Job Board that Entirely People has subscribed access to; public social networking sites, such as LinkedIn, or other publicly accessible sources; when you have been referred to us.

### What personal information will we process?

This may include (but is not limited to); name, name of organisation, job title, phone number, work email address, links to public professional profiles.

### Where do we get your data from?

## The Website

You can visit our website without giving away your personal information. Entirely People Limited uses Cookies and may use this information in order to analyse how the website is used. It is not used for any additional purpose, such as to profile those who access our website and no personal data is processed. This information will be processed in accordance with our policy on Data Processing (see earlier) so that it is possible for us to contact and respond to your request, and / or allow you access to our services.

## Information Security

Entirely People Limited seeks to ensure the security of personal data. When we collect information about you, we also make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical and organisational measures.

## Access to information

You have the right to request access to the information we have on you.

We will make sure to provide you with a copy of the data we process about you. In order to comply with your request, we may ask you to verify your identity.

We will fulfil your request by sending your copy electronically, unless the request expressly specifies a different method. For any subsequent access request, we may charge you with an administrative fee.
